CHINA'S NEW DEVELOPMENT MODEL: IMPACTS ON AFRICA AND LATIN AMERICA

The conference will focus on the changing patterns of the development strategy of China, from an export-oriented, manufacturing-intensive growth model to a more consumption-oriented, services-intensive growth model, and on the identification of the threats and opportunities that it represents for the African and Latin American countries' growth and development performance. The conference will provide an opportunity for experts on the Chinese economy to talk about the features of the new development model, in terms of (a) its impact on Chinese growth; (b) aggregate demand rebalancing; (c) supply-side changes; and (d) effects on global markets.¹

African, Asian and Latin American economists will discuss the implications for their respective regions. More specifically, they will debate about the current linkages between these emerging regions and China, and how changes in that country might propagate to its economies.

SPEAKERS' BIOGRAPHIES

Xiaobo Zhang is a citizen of China, Zhang earned a B.S. in Mathematics from Nankai University, China; a M.S. in Economics from Tianjin University of Economics and Finance, China; and a M.S. and a Ph.D. in Applied Economics and Management from Cornell University in January 2000. He is a distinguished professor of Economics and Deputy Dean at the National School of Development at Peking University. Zhang joined the International Food Policy Research Institute (IFPRI) in 1998. He has published widely in the fields of economic growth, income distribution, public investment and rural industrialization in China and other developing countries. He is a co-editor of Chinese Economic Review. He was elected as President of the Chinese Economists Society in 2005-2006.

Cai Fang, graduated from the Agricultural Economics Department at Renmin University of China in 1982. Cai received a Master's Degree in Economics from the Graduate School of the Chinese Academy of Social Sciences in 1985 and earned a Doctorate in Economics from the same institution in 1989. Since serving as a deputy researcher at the Institute of Rural Development at the Chinese Academy of Social Sciences, Cai has held several leadership positions with the academy. He was the deputy director of the academy's Institute of Population Studies and then he was dean of the Demography Department at the academy's graduate school. A former chief editor of the Chinese Population Sciences magazine, Cai later directed the academy's Institute of Population Studies. He is the co-author of "The Miracle of China, Development Strategy and

Economic Reform," "The Chinese Ongoing Agricultural Economic Reform," and "Competition, Policy Burden and Reform of State-Owned Enterprises" with Lin Yifu and Li Tong.

Rolando Avendaño is an Economist at the OECD Development Centre, working with the Americas Desk. His research focuses on different areas of financial economics, with special interest in financial development, sovereign wealth funds and Asia's impact on emerging economies. Prior to joining the Centre, he worked with the University of Los Andes, the Institute of Latin American Studies (UCL, London) and the OECD Economics Department. Rolando holds a B.Sc. in Industrial Engineering and Operations Research from University of Los Andes (Bogotá) and a B.A. in Anthropology, jointly University of London. He completed a Master and Ph.D. in Economic Policy Analysis at the Paris School of Economics.

Mauricio Mesquita Moreira is Trade and Integration Principal Economic advisor and Research Coordinator of the Integration and Trade Sector of the Inter-American Development Bank (IDB). He received a Ph.D. in Economics from the University College London. Prior to joining the Bank, Mr. Mesquita Moreira served at the Research Department of the Development Bank of Brazil (BNDES), and taught at the Federal University of Rio de Janeiro, Brazil. He is the lead author of "Too Far to Export: Domestic Transport Costs and Regional Export Disparities in Latin America". IDB, 2013; "Shaping the Future of Asia and Latin America Relations". IDB and ADB, 2012; "India: Latin America's Next Big Thing?" IDB, 2010; "Unclogging the Arteries: A Report on the Impact of Transport Costs on Latin American Trade". IDB and Harvard University Press 2008, and "Ten Years After the Take-off: Taking Stock of China-Latin America and the Caribbean Economic Relations among other studies". IDB 2010, among others.

Pedro da Motta Veiga is Director of Center of Integration and Development Studies (CINDES) of Brazil and director-partner of Ecostrat Consultores. He is a permanent consultant for the Confederação Nacional da Indústria (CNI) of Brazil and for the Swiss Agency for Development (SDC). He coordinates the activities of the Latin American Trade Network (LATN) in Brazil. He has also acted as consultant for many international institutions such as the IDB, World Bank, OECD, UNCTAD, CEPAL and ALADI.

Margaret Myers is director of the China and Latin America program. She received a BA in Foreign Affairs from the University of Virginia and conducted her graduate work at The George Washington University, Zhejiang University of Technology, and the Johns Hopkins University/Nanjing University Center for Chinese-American Studies. Prior to arriving at the Dialogue, she worked as a Latin America and China analyst for the US government, which required her to travel throughout Latin America and East Asia. Margaret also worked as a Senior China Analyst for SAIC and as a Spanish and Chinese teacher in Virginia Public Schools. While at the Dialogue, Margaret has published numerous articles in American, Latin American, and Chinese journals and news outlets.

Mina Baliamoune is the Director of Research at ACET. Dr. Baliamoune has a wealth of experience in research and teaching, having published numerous journal articles and book chapters on topics related to economic transformation in Africa. She has taught at university level in the US and Morocco for nearly 18 years, and is currently on leave from the University of North Florida. Dr. Baliamoune has been referee of many academic journals, and has recently served as President of the African Finance and Economics Association (AFEA). She is also Associate Editor for the "Journal of African Development and Information Technology for Development".

Lawrence Edwards is an Associate Professor in the School of Economics, University of Cape Town. Lawrence graduated with an MSc in Economics from the London School of Economics in 1998. He completed his PhD in Economics at the University of Cape Town in 2003. Lawrence's research falls within the field of international trade with a specific focus on international trade and labour, the determinants of trade flows and economic adjustments to trade liberalization. He has published in a number of international and local journals including World Development, Journal of International Development, South African Journal of Economics and Journal of Studies in Economics and Econometrics. He has also consulted widely for the World Bank, the National Treasury, the Department of Trade and Industry and is currently a member of the South African Growth Project managed by the Centre of International Development at Harvard University.

Melaku Desta joined the Leicester De Montfort Law School in September 2013 as Professor of International Economic Law. Prior to that, Melaku worked at the Centre for Energy, Petroleum and Mineral Law and Policy (CEPMLP), University of Dundee, Scotland, for over twelve years. At CEPMLP, he worked as Teaching/Research Fellow (July 2001-June 2002), Lecturer (June 2002-September 2004), Senior Lecturer (October 2004-September 2007), and Reader in International Economic Law (October 2007-August 2013). During his time in Dundee, Melaku served as programme leader for the LL.M. degrees in International Business Law and Transactions (July 2001-August 2013) and in International Dispute Resolution and Management (September 2006-August 2013), as Director of the overall LL.M. Programme (September 2006-September 2008), and as Director of the Ph.D. Programme (September 2008-August 2013).

Pablo M. García is Trade and Investment Lead Economist at the Inter-American Development Bank (IDB). He is in charge of the IDB Regional hub for trade and investment activities in Argentina, Brazil, Chile, Paraguay and Uruguay, where he leads the design and implementation of projects related to export promotion, investment attraction and trade in services. He is also in charge of the IDB cluster for trade and investment promotion. Previously at the IDB he has held country economist and coordinator positions. He has authored several works and studies on international economy, trade in services, and intra-industry trade. He has also taught at Georgetown University and at the University of Buenos Aires. Mr. Garcia holds a Master's degree in International Commerce and Policy at George Mason University, a Master's degree in Economics at Di Tella University and a BA in Economics at the University of Buenos Aires.

Guillermo Rozenwurcel is Executive Director of the Center for Ideas (Research on Economic Development in South America) at the National University of San Martín. Mr. Rozenwurcel holds a Master's degree in Economics at Pontifical Catholic University of Rio de Janeiro and a BA in Economics at the University of Buenos Aires. He is Independent Researcher at the Argentinian National Council of Scientific and Technological Research (CONICET) and professor at the University of Buenos Aires and National University of San Martín. In the public sector he has served as Secretary of State for Small and Medium Enterprises (1999-2000) and Vice Chief of Staff of the Argentinian Ministry of Economy (2000-2001).

Andrés López is Executive Director of the South American Network on Applied Economics/Red Mercosur and Director of the Economic Department of the University of Buenos Aires. Mr. Lopez holds a Ph.D. in Economics from the University of Buenos Aires and is professor of Development Economics at the same University. Mr. Lopez is also Director of CENIT and researcher at the Argentinian National Council of Scientific and Technological Research (CONICET). His area of specialization is industrial economics and technological change.

Leonardo Villar is Director of Fedesarrollo, the principal private research center in Colombia. Previously, he was Chief Economist and Vice President of development strategies and public policy at the Corporacion Andina de Fomento (CAF) based in Caracas. In the public sector, he was co-director of the Bank of the Republic from 1997 to 2009, technical deputy of finance from 1994 to 1997, and also served on the Advisory Board of Foreign Trade. Additionally, Villar served as a member of the research group at Fedesarrollo. Mr. Villar holds a Master degree and BA in Economics at Universidad de los Andes, Colombia and a Master of Science in Economics at London School of Economics.
